3 Thereafter, the President of SPMA, by communication dated 07.10.2023, has submitted that from the academic year 2017-18 onwards uniform fee structure of the paramedical diploma courses in their member colleges fixed by the Committee for the merit and the management quota seats was Rs.

61,000/- and that the tuition fee for the Diploma Courses fixed as per order dated 06.10.2023 may be modified by granting 10 % increase.

- Committee has considered the request of SPMA in the meeting held on 14.11.2023 and found that the inadvertent mistake crept into order dated 06.10.2023 of this Committee needs to be corrected. Hence, the Committee has decided to issue this erratum order.
- **5** Accordingly, paragraph 17 of order dated 06.10.2023 wherein the calculation table for Diploma Courses is shown shall stand modified as recorded below:

- 7. As regards the request made by SPMA to revise the fee structure of B.Sc Optometry course the College is informed that its request cannot be entertained at this stage, because, revising decisions taken or orders issued by FRC, which have become final, is not legally permissible. It is open to SPMA to propose the fee structure as may be necessary when that exercise is taken up for the next year.
- **8.** Email this order to the Government of Kerala and the Principals of the Self-Financing Paramedical Colleges in Kerala which come under the SPMA. Government of Kerala may notify the fee structure for the academic year 2023-24 as per section 9 (2) of Act 15 of 2017.
